



The Patna Congress – My Views

This was my 6th National Congress, starting from Chennai when the first steps to form the National Federation were taken, on to Kolkata, Mumbai, Jamshedpur, Trivandrum and now to Patna. And every congress was great and yet different as it should be bringing with it the flavour of the venue. The Patna Congress was special because of its international flavour with members of the committee of the World Union of Jesuit Alumni present, including the President, Mr. Tom Bausch and Fr. Bill Currie s.j. from Japan, the Jesuit advisor appointed by Fr. Superior General.

Looking back, I ask what I have gained from the Congress. First of all the dedication of the Patna alumni who worked so hard for the Congress's success, and did it in such a friendly and yet efficient way. Then of course the new friends I made and the old friends I met again. The topic "Public Private Partnership in Education" was well presented by competent speakers. However maybe the main thing I took away was the challenge which our new secretary Shapath keeps on reminding us of. What will be the follow up? Or will this congress, great to build connections, surely an important product of the congress, finally end in papers on the topic and that is all.

In fact the topic is not so easy to follow up. Our alumni associations can certainly help schools for the poor, are already doing so, and this will be a contribution to public private partnership. But the topic seems to be looking at the bigger screen, how government and private agencies can finance and guide government educational institutions. One of the presenters said plainly that the government alone cannot produce quality education.

Where is our expertise? I think our expertise is in our organizational ability and our knowledge of what quality education is. And what is the possible

difficulty? Will state education departments be ready to allow us to organize and run government schools in a block, a sub division? To show that by private public partnership, a model educational block, model educational sub division is possible. In the 1970's in Mahadmar block of undivided Bihar, the government gave the Jesuits the running of a school complex for the whole block. That meant regular meetings with all the teachers, government and private, of the block. It meant setting of examinations, evaluation of the annual examinations of all the schools of the block. It went well for some time but the culture of many government teachers was not in tune with the Jesuit culture of commitment to the students and sometimes the government schools did not have sufficient teachers.

Maybe we also had not planned carefully enough how the Jesuit school of the place and the government should work together. Can this be tried again? Will the education department be ready for real partnership, not in giving additional finance to the education department but in providing expertise?

We as a National and State organization can approach the education department and find out what help they are looking for, find out if they are serious. Especially we want to find out if they are simply asking for finance or are looking for educational expertise. If they are ready, and it may happen in some states, that is wonderful. We commit ourselves. If the particular education department is not ready, then the national or state alumni organization should put forward a project for the state alumni associations, even though, it may not directly follow on the national congress. We have immense potential. It must be tapped, not only on the local level, but also on the national and state levels.

The World Union of Jesuit Alumni (WUJA) had co-incided their governing council meeting along with this Congress and hence, there were 12 foreign delegates at the Congress. This is my 1st circular as the President, and I would like to give you brief details about the zonal structure of our country. India is divided into four Jesuit Zones. They are - 1. West Zone comprising Bombay, Goa, Pune and Surat. 4. South Zone comprising Andhra, Karnataka, Kerala and Madurai.

It is my feeling that the success of Jaai depends on the success of Zones. These four Zones are your link with Jaai. All Zones have their respective active governing councils. So I request all alumni associations to take active part in the zonal activities and programmes.

Last month, I had the opportunity of attending the international convention of St. Xavier's College Alumni Association, Calcutta at Dubai. It was a wonderful event, all the more so because SXCAA is organizing its foreign conventions every year in a country having their chapters. This is appreciable since through these conventions, Xaverians settled abroad are able to be in touch with their Alma Mater and able to extend their helping hand too.

On the eve of my handing over of the Secretaryship of JAAI, I feel I should communicate with you on a few issues of common interest.

The past three years have been both eventful and exciting. All of us in the Governing council have put in their best efforts to ensure an all round development of the zones as well as of the parent body.

Governing Council Meetings:

During the last three years the G.C. members were in touch with each other by email on a daily basis through group mail. In all, five G.C. Meetings were held as per following details - On 9th Sept, 2007 at Loyola, Trivandrum, then on 9th Feb, 2008 at St. Vincent's, Pune, then on 17th Jan, 2009 at St. Xavier's, Kolkata, followed by another 7th March 2010 at St. Xavier's, Patna, further on 14th Nov, 2010 at St. Xavier's, Delhi, and finally on 4th Feb, 2011 at St. Xavier's, Patna.

Networking & Communications:

Since the last Congress, ten Secretary's circulars have been sent to all registered members. The Secretary started a periodical SMS service to inform everyone about events through texts on registered mobile numbers. The JAAI website: www.jaaindia.com is regularly updated with news, pics, videos and links.

New Superior General and Provincial of South Asia:

Rev. Fr. Adolfo Nicolás, s.j. was appointed as the new Superior General in Jan, 2008. Fr. Adolfo is from Spain and was previously in Japan for 40 years. He is very well read and erudite, quite like Fr. Anippe. The Jaai GC Members had an audience with him on Saturday, 21st Feb, 2009, at 4.15 pm at St. Xavier's, Delhi. In India, Rev. Fr. Edward Mudavassery, s.j., was appointed as the new Provincial of South Asia in 2009. Fr. Edward is from the Hazaribagh province. He is nurturing Jaai as a friend, philosopher and guide.

Audited Accounts & Subscription:

It was voiced during the last Congress at Trivandrum, that the financial affairs of the Federation should be shared on an annual basis. Accordingly, I have circulated copy of the audited accounts for all the years. I would like to place on record my deep appreciation for the untiring efforts of Sri Santosh Agarwal for keeping the accounts updated. My sincere thanks also to our Auditors - M/s. Ajay Tekrwal & Co. During these three years Jaai has registered six new members taking the tally of registered members to 100 and we have on our mailing list names of 29 unregistered members. We have collected Rs. 1,10,000/- as subscription from 1st Dec, 2007 till 31 Dec, 2010 and have paid U.S \$ 10,000 as the World Union dues.

Rejuvenation of the Alumni/ae Associations:

Since the last Congress many dormant/inactive alumni/ae associations have become active. This was possible due to better communication and net working of Associations with Jaai Zones. I request zonal representatives to reach out to all the Jesuit institutions/associations in your region and try to inform associations about the zonal/national/international structure of Jesuit Alumni movement.

Voice of JAAI Land and ETC - World Union newsletter

Since the last congress two issues of Jaai news letter - Voice of Jaai have been printed and circulated to all and similarly two issues of ETC - World Union news letter were copied and circulated.

Seventh World Congress

The seventh World Congress of Jesuit Alumni/ae was held between 22-27 July 2009 at Bujumbura, Burundi: the land of 1001 hills, in the heart of Africa. It was the first ever Congress in the African continent and was attended by over 170 people from across the globe. In the Indian delegation comprised 20 members including 11 Alumni/ae (2 woman) & 9 Jesuit Fathers. St. Xavier's College (Calcutta) Alumni Association represented by

6 members was the largest. North Zone had 9 delegates, followed by 5 from South and 3 each from Central & West. The Indian delegation was the largest national delegation. The 35th General Congregation of the Society of Jesus had focussed on Africa and hence the Congress was christened as "Hope" and the theme was "For a better Africa: What have we done? What are we doing? What should we do?". The Indian Federation was given a special slot to show case its projects & progress. JAAI Secretary, Naresh Gupta along with Rev. Fr. Felix Raj, Conrad Goswales & Ronald D'Costa, exhibited a power point presentation to highlight our achievements. Since there are no Universities in the Great Lakes region, hence, the Indian delegates invited Africans to come to India for higher studies. They were also assured of scholarships. Mr. Ronald D'Costa is treasurer of WUJA and Mr. Naresh Gupta and Mr. Shaphath Shah are governing body members.

The 8th Congress of the World Union of Jesuit Alumni/ae will be held from 14 - 18 August 2013 at the Medellín - Colombia. The theme of the Congress is Ignatian Leadership with Social Responsibility. "We were educated, let's educate".

World Congress Follow Up: A 17 year old Colombian student - Master Santiago, arrived to study English at Loyola, Jamshedpur. The WUJA vice president Mr. Alain Deneuf came to Calcutta to do research on the contribution of Belgian Fathers in India. Two alumnus from Congo attended the 150 years celebrations of St. Xavier's, Calcutta in January 2010. Three girls arrived from Bujumbura, Burundi for advanced studies at St. Joseph's College, Darjeeling.

Zonal Congress

All the four zones have organized their Congresses since the last National Congress.

Grant of Rs. 15000: The motto of our federation is - "To Give and not to count the cost" and to be "Men and Women for Others". Hence, associations were encouraged to undertake some project of public utility/social benefit with a minimum budget of Rs. 30000/-, where in Jaai would have contributed upto Rs. 15000/-. Four associations were given grants namely - Loyola - Jamshedpur, Masi Marsal - Hazaribagh, St. Xavier's - Kolkata & Loyola - Hyderabad.

AEP - Spain: A first ever in the history of JAAI. A five member JAAI team went to Spain on 19th Sept 2008 under the Alumni Exchange Programme for 8 days. The 2nd group of Spanish Alumni members comprising seven girls and two boys came to Jamshedpur/Kolkata in 2010 and worked with NGO's for a week.

St. Xavier's, Calcutta: At the closing ceremony of the sesquicentennial celebrations of St. Xavier's, Kolkata, on 16th Jan 2010, the chief guest was the Hon'ble Prime Minister, Dr. Manmohan Singh. It is a matter of pride that the St. Xavier's Collegiate School students of the batch of 1986 have raised Rs. 2 Crores to be utilised by their ex teachers. Kudos to them!

Obituary:

Fr. Vincent Duminico - past Jesuit Counsellor to WUJA, Fr. Herman Castellino - past national advisor to Jaai and Fr. Chandy moodiyil - Patna province co-ordinator and a few other Jesuits did not pass away. We condole their death. May God give peace to the departed souls.

Visitation:

In the past three years I visited/attended the events of World Congress at Bujumbura, Abaco-Kolkata, Sreeca-Kolkata, Slobs-Kolkata, Raighabpur, St. Xavier's-Durgapur, North Point, St. Vincent's-Pune, St. Xavier's-Jajpur, St. Xavier's-Delhi, Loyola-Jamshedpur-Central Zone, North Zone etc.

The end of a Secretarial term also beckons the beginning of another. Therefore, as I prepare to take leave of you as Secretary, I would like to take this opportunity to place on record my deep and personal gratitude for the unstinted support, which all of you including the Jesuit Fathers, the President, all past presidents and my colleagues on the Governing Council have extended. It goes without saying that without such strength, I would have found it difficult to discharge my onerous responsibilities as the Secretary.





PPP Is No Panacea

Public-Private Participation (PPP) is a must to attain education goals and yet PPP is no panacea. The Vith National Congress of the Jesuit Alumni/ae Association of India (JAAI) commenced on the evening of 4th February 2011 to debate Public-Private Partnership for Better Education. At the inaugural ceremony the Chief Guest Rev. William D'Souza, SJ, Archbishop of Patna, expressed the hope that the deliberations would result in positive solutions while being mindful of the core concerns of education. His Grace blessed the occasion in a speech that indicated purpose and aim.

The Bihar HRD Minister, Mr. P.K. Sahi, the guest of honour at the inaugural ceremony, made an impassioned appeal to Jesuits and sought collaborative partnership with Corporate and Private Entrepreneurs to share the government's efforts to meet the huge deficit in education. The President of JAAI, Dr. Santosh Rolland drew an interesting parallel between the credo of JAAI namely, Excellence, Innovation and Honor which any PPP initiative in education should transcribe into its model to blend its excellence and emancipation. President of the World Union of Jesuit Alumni, Dr. Thomas Bausch commended the excellent work of the Jesuits. PPP should focus on the concerns of the disadvantaged, he maintained. Mr. J.K. Sinha, President of the SXAA, Patna and former Joint Director RAW spoke of corporate social responsibility that ought to urge the private players to engage with the country's education program.

Fr. Joy Kamayapuram, SJ Provincial and Fr. Ignatius Arun Abraham, SJ, Moderator of SXAA and Rector St. Xavier's Patna, expressed the hope that the deliberations on Public-Private Partnership would harmonize excellence and worth on one hand and ethics on the other. The program was ably anchored by the Secretary of SXAA, Dr. Anujay Singh. Dr. Sandeep Sen, Vice President of SXAA and Treasurer of JAAI thanked all the guests and delegates for their purposeful contributions and participation.

Over 400 Jesuit alumni and 40 Jesuit priests from India and countries such as USA, Australia, Belgium, Brazil, Burundi and France attended the Congress. Mr. Pablo Diaz, Ambassador of Chile to Australia was among the many dignitaries to grace the occasion and participate with avid camaraderie on the deliberations that took place on the constructive role of the Alumni/ae in the context of PPP.

On day-2 at the plenary session, Mr. N.K. Singh, well known bureaucrat and Rajya Sabha member enumerated the various challenges and worries that the education faces today as we switch from a static socialistic economy to one that offers a wider global choices increasing competition and catapulting economic growth. The challenge of PPP was to reconcile the irreconcilable.

The contradictions that one has to engage with are the effort to harmonize access with quality, the need to pay for the quality and the commercialization of education. He called for a flexible approach to tide over the crisis of resources.

Professor Jitu, Singh, Professor of XLIJI, Jamshedpur, questioned the usefulness of the RTE if inadequate and non-quality education was to be provided. He called for the Public and Private sectors to merge their resources in order to tackle the dual problem of creating educational infrastructure and a good teacher. The resources, he said, should be pooled in for purposes with focused priorities.



Back to JAAI Business

It has been a while since we are back from the Patna National now, and I am sure we have all settled back in our respective fields back home in different parts of the country. Most of us would have avidly followed the cricket world cup, and IPL that happened soon after. After India tasted success and are new World Champions, we must have relaxed and basked in the glory of the victory.

But now it is time once again to get down to our JAAI business end. Next on should be the confirmation of the proposed Blood Donation Drive on October 2. This should be a simultaneously carried out by all Jesuit Alumni/ae Association around India as well as our G.C. members and province Coordinators have supported this cause and date. Please dwell on this and let us finalise this noble activity.

Also the JAAI newsletter, with a report on Patna Nationals and other events from Associations around the country is what you are reading now. We also will strive to keep the JAAI website updated and active with the same news and

- School & Alumni website:** The school website http://stanislansbandra.in is maintained by the Ex-students Association. We help connect alumni with their school through the alumni portal http://stanislans.org an interactive portal where alumni share their experiences past and present.
- Staff Healthcare Scheme:** This project has been fully funded for the last four years by our alumni from across the world. 126 teaching and non-teaching school staff (current and retired) are provided with Health insurance of Rs 1 lakh each.
- Independence Day Alumni Football:** Alumni from St. Mary's ISC, Holy Family, Andheri and St. Stanislaus played against each other reliving the exultant competitive spirit between Jesuit institutions.
- Band of Boys 2011:** Alumni reunion was held on 8th and 9th January 2011 and included walk around the school, inter-house box cricket and reunion night.

Darjeeling on the Move Again

After somewhat of a forced lull in our St. Joseph's School Alumni Association during all the strikes, shut-downs of the past two years, when it was impossible to organize anything, let alone have meetings, peace has come back to this Himalayan outpost. We have held an AGM, have held elections to the executive. Sunjay Singh became the President, Deven Gurnung the Secretary. We have held about four meetings for planning. On July 23 we had a Friendship evening for which there has been a lot of publicity. On August 27 we will be holding an inter-school quiz with perhaps 30 schools participating, something we had been doing for for many, many years, before the agitation. Committee it is a wonderful feeling to be able to be active once more. We will certainly be sharing in the JAAI all India blood camp on October 2. Committees have been formed to organize other activities to tackle such things as Children Labour problems. One of our men had formed an NGO a few years back to make it possible for Village children in parts of the district to start attending schools, a thing that had been impossible in the hinterland. They have also helped to have a human trafficking ring to be arrested by the police, and several girls returned to their homes in Darjeeling and Sikkim, who had been promised jobs in Bangalore, but it was for other purposes. Parents are becoming aware of how easily their daughters can be tricked.

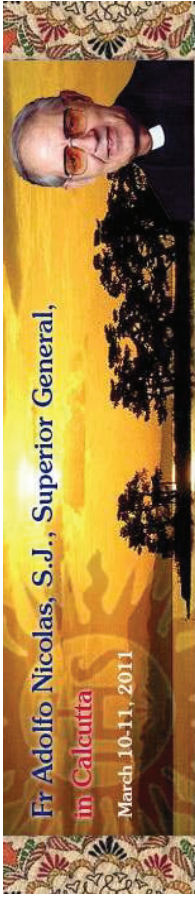

When the powerpoint about the Santal ministry was to begin, the 'panchi' was almost falling, and so Fr General requested it to be tightened, which was promptly done for him. This time it remained intact till the end of the program. Was it an indirect call from Fr General to 'tighten' our ministry to the Santals in the Province?

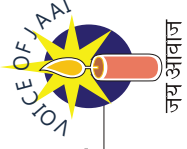

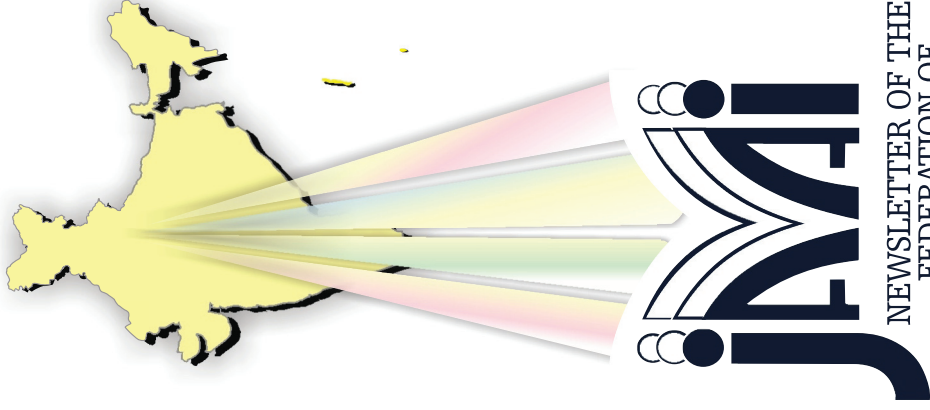
